Roy Learned Advocate.</p> <p>For the State Respondents : None.</p> <p>The Vakalatnama filed by the applicant is kept on record.</p> <p>None appears on behalf of the Respondents.</p> <p>The applicant has prayed for direction upon the respondents to grant interest on arrears of salary paid to the applicant.</p> <p>The applicant was implicated in a criminal case being Mathabhanga PS Case No. 14 dated February 14, 1997 under Section 420/468/471 of Indian Penal Code, while the applicant was working as Upper Division Clerk in the office of Sub-Divisional Officer, Mathabhanga in the district of Coochbehar. The applicant was suspended for detention in custody exceeding forty eight hours. The order of suspension was challenged by the applicant before this Tribunal by filing OA No. 1186 of 2005 which was disposed of on November 7, 2006, whereby the order of suspension was revoked and the applicant was reinstated in service. The applicant again approached the Tribunal by filing OA No. 8034 of 2008 which was disposed of on February 16, 2010, whereby the Tribunal directed the concerned respondent for re-examination of fixation of pay of the applicant and to refix the same, if necessary, within specific period of time. The applicant was acquitted of the charge by the Criminal Court by delivery of judgment dated February 8, 2012. No document is forthcoming</p>

Rajib	<p>before the Tribunal how and when the judgment passed by the Criminal Court was communicated to the Sub-Divisional Officer, Mathabhanga, who refixed the pay of the applicant by order no. 327 dated June 1, 2012. On the basis of the said order, the Respondent No. 4, Sub-Divisional Officer, Mathabhanga sanctioned a sum of Rs.1,88,579/- on August 13, 2012 and a sum of Rs.4,38,176/- on October 9, 2012. Nothing is on record to indicate when the said amount of money was actually received by the applicant.</p> <p>Under the above factual matrix, Learned Counsel for the applicant contends that the pay of the applicant needs to be refixed by the Respondent No. 3. We do not find any relevance of the submission made by the Learned Counsel for the applicant. In view of the fact that the applicant was acquitted of the charge by the Criminal Court on February 8, 2012 and the order for fixation of pay of the applicant was passed by the Respondent No. 4 on June 1, 2012 and sanction order for payment of arrears of salary of the applicant to the tune of Rs.6,26,755/- was passed by the Respondent No. 4 on August 13, 2012 and on October 9, 2012, we are constrained to hold that there is no delay in payment of arrears of salary for which the applicant is entitled to get interest.</p> <p>In view of our above observation, the application is dismissed.</p> <p>Let a plain copy of the order be supplied to the applicant.</p> <p style="text-align: center;"><b>(Dr. S.K.
