The applicant is a Group D employee and his GPF account is maintained in the office of respondent No. 7, Block Medical Officer of Health, Gopiballavpur-I. the respondent No. 7, Block Medical Officer of Health, Gopiballavpur-I will disburse the amount of money deposited by the applicant in the GPF account along with interest accrued thereon till the date of disbursement of the said amount. The applicant is directed to submit application in the prescribed format by disclosing all necessary information including the bank details of the applicant before the respondent No. 7, Block Medical Officer of Health, Gopiballavpur-I within a period of eight weeks from this date. If such application is submitted by the applicant within the specific period of time, the respondent No. 7, Block Medical Officer of Health, Gopiballavpur-I is directed to take steps for disbursement of the amount of GPF within a period of eight weeks from the date of submission of the application in the prescribed format, if the amount of GPF has not been released in the mean time.

With the above direction, the original application stands disposed of.
