	The applicants have prayed for direction upon the respondents for	
	disbursement of the wages in terms of G.O. No. 3727-F dated May 20,	
	2009 issued by the Finance Department, Government of West Bengal.	
	The contention of the applicants is that they have been engaged as	
	part- time Sweeper-cum-Water Carrier of different R.I. Offices attached	
	to the Block Land and Land Reforms Officer in the district of Nadia. The	
	further contention of the applicants is that they have been granted	
	enhanced wages @Rs.2000/- p.m., but the arrears of wages have not	
	been disbursed till date. On our query, Learned Counsel for the	
	applicants submits that the applicants have not yet submitted any	
	representation before the concerned respondents for disbursement of	
	arrears of wages in terms of G.O. No. 3727-F dated May 20, 2009.	
	Learned Counsel for the applicants has prayed for direction upon the	
	respondents for release of arrears of wages of the applicants on the	
	ground that the applicants of OA No. 995 of 2017 have already got the	
	order from the this Tribunal on April 25, 2018.	
	Having heard Learned Counsel representing the applicants and the	
	Departmental Representative of the State respondents, we are of the	
	view that the applicants should first submit representation before the

concerned respondents for consideration of their case and thereafter they should have approached the Tribunal in case of any inaction on the part of the concerned respondents.

In view of our above observation, the applicants are at liberty to submit representation before the Respondent no. 4, Additional District Magistrate and District Land and Land Reforms Officer, Nadia for the purpose of enhanced wages and arrears of wages in terms of G.O. No. 3727-F dated May 20, 2009 issued by the Finance Department, Government of West Bengal within a period of 4 weeks from this date. If such representation is submitted by the applicants, the State respondent No. 4 will consider the representation of the applicants in terms of order passed by the Special Bench of the Tribunal on April 16, 2012 in OA No. 1304 of 2011 within a period of 8 weeks from the date of submission of the representation by the applicants and to take necessary follow-up action within a period of 4 weeks thereafter. The applicants are directed to enclose copy of order dated April 16, 2012 passed by the Tribunal in OA No. 1304 of 2011 along with the representation to be submitted by them within the stipulated period of time.

With the above direction, the original application is disposed of.
