The further contention of the applicant is that Director of Fisheries has already issued order on May 30, 2017 in terms of the above memorandas issued by the Finance Department, Audit Branch, Government of West Bengal, but the said order dated August 30, 2017 has not yet been implemented.

None appears on behalf of the State respondents in spite of service of notice, except the respondent No. 4. However, now respondent No. 3 is duty bound to implement the order dated August 30, 2017 for the purpose of giving arrears of salary to the applicant within stipulated period of time.
