The applicant has prayed for direction upon the respondents for payment of remuneration in terms of memorandum no. 9008-F(P) dated September 16, 2011, memorandum no. 4011-F(P) dated March 20, 2013, memorandum no. 1107-F(P) dated February 25, 2016, memorandum no. 1033-F(P) dated February 8, 2019 and memorandum no. 3998-F (P) dated July 15, 2019 issued by the Finance Department, Audit Branch, Government of West Bengal and other ancillary reliefs.

It appears from the materials on record that the applicant has been working temporarily in the establishment of the respondent No. 4, Block Development Officer, Tufanganj-II, Cooch Behar as Water Carrier since his engagement on November 10, 2008. The applicant was receiving monthly remuneration @ ₹ 700/- per month at the time of filing of the original application. Presently, he is drawing remuneration @ ₹ 2000/- per month w.e.f. July 01, 2017. The contention of the applicant is that he was deprived of enhanced monthly remuneration in terms

Sufficient materials have not been placed before us to decide about the entitlement of the applicant to get remuneration in terms of memorandum dated September 16, 2011 and the subsequent memorandums issued in this regard as prayed by the applicants.

In view of our above findings, the respondent no. 2, District Magistrate, Cooch Behar is directed to consider whether the applicant is entitled to get financial benefits in terms of memorandum no. 9008-
