	Giri, predecessor in interest of the applicants died-in-harness on	
	January 4, 2015, but entries have been made in the service book till	
	February 5, 1991. The information is not furnished whether the	
	deceased employee discharged any duty during the period when	
	his service was declared as "dies non" till his death on January 4,	
	2015. Nor have the applicants impleaded all the legal heirs either	
	as applicants or as respondents in the original application. Under	
	the above circumstances, we are not in a position to decide the	
	issue of granting family pension and retirement benefits to the	
	applicants without disclosure of full facts and without impleading	
	all the legal heirs as parties in the original application.	
	Liberty is given to the applicants to file supplementary	
	application disclosing full facts of discharge of duty by the	
	deceased Government employee by impleading all the legal heirs
