On consideration of prayers of the applicant, we find that the applicant has prayed for refixation of pay, quashing of departmental proceeding and for release of pension and other retiral benefits. Rule 10 of West Bengal Administrative Tribunal (Procedure) Rules, 1994 clearly lays down that an application shall be based upon a single cause of action and one or more reliefs may be prayed if they are consequential to one another. In the instant case, prayer for release of pension may be consequential to refixation of pay or quashing of departmental proceeding, but refixation of pay and quashing of departmental proceeding are not based on same cause of action. Accordingly, the applicant is directed to make amendment of prayer portion of the application in accordance with the provisions of Rule 10 of West Bengal</p>
