No. 1107-F(P) dated February 25, 2016 issued by Finance Department, Audit Branch, Government of West Bengal.</p> <p>The applicant claims to be daily rated casual worker of the establishment of respondent no. 5, Sub-Divisional Officer, Chanchal, Malda. The contention of the applicant is that he has been working as daily rated casual worker w.e.f. February 10, 2006. The further contention of the applicant is that the respondent no. 5 issued order dated May 23, 2016 for giving remuneration to the applicant @ Rs.16,000/- per month on the basis of G.O. dated September 16, 2011 and subsequent G.O. dated February 25, 2016, but the said order has not been made effective till date. Mrs. Mitra, Learned Counsel for the applicant, contends that the financial benefit should be given to the applicant on the basis of the Government Orders issued by the Finance Department, Audit Branch, Government of West Bengal.
